Of India, Company's Corporate Office, Faridabad invites applications from eligible candidate for 01 year Apprenticeship Training in different ITI Trades of Draughtsman (Civil) & Draughtsman (Mechanical), Computer Operator and Programming Assistant, Secretarial Assistant, Stenographer (Hindi) and Health Sanitary Inspector. - 1. **Stipend**: The stipend will be paid as per Apprenticeship Act, 1961.
- 2. **Age:** The age of the candidate should be between 18 to 25 years as on the day of application i.e. on 12.12.2022. A relaxation in upper age is admissible as per the Govt of India guidelines for SC/ST/OBC/PH.

3. Reservation:

Guidelines under Apprenticeship Act on Reservation for SC/ ST/OBC/EWS/PwBD will be followed. Applicants who are claiming reservation under above categories shall provide certificate as per Government standard format issued by the Competent Authority, failing which their claim for reservation will be considered as 'General' category only.

- 4. **Minimum Physical Standards:** As prescribed in clause 4 of the Apprenticeship Rules 1992 and amendments thereof if any.
- 5. **Duration of Training:** The duration of the training will be one year and contract would be terminated automatically after completion of the apprenticeship training period. Shortlisted candidates have to furnish undertaking that after completion of training they cannot demand employment.
- 6. **Preference**: Preference for selection of Apprentice Trainees will be given as under:
 - (i) First preference will be given to candidates belonging to Faridabad district.
 - (ii) Second preferences will be given to candidates belonging to Palwal/ Gurgaon.
 - (iii) Third preferences will be given to candidates belonging to other districts Haryana state.

- 9. Selection Process: Selection of Apprentice Trainees shall be on the basis of Marks secured in ITI. If two or more candidates secure equal marks while preparing merit list, then the candidate of higher age will be considered. List of selected trainees shall be published in career section of nhpcindia.com website. Contract will, however, be generated in respect of the selected candidates on the website www.apprenticeshipindia.org against the applications of the candidates. The information about issue of contract shall automatically be sent to their registered Email-ID. Candidates will be required to ACCEPT the offer in their e-mail as well as SIGN the contract on the website www.apprenticeshipindia.org.
- 10. Candidates, who have already undergone Apprenticeship Training, should not apply.
- 11. **Employment in NHPC**: The training duration shall be of one year. The Apprentice Trainees shall have no claim, whatsoever, as to any extension of training and / or employment in NHPC.
- 12. No boarding/lodging & transportation shall be provided to any candidate by NHPC Limited.
- 13. Apprentice selection and Training shall be governed by detailed provisions of Apprenticeship Act, 1961.
- 14. In case of any ambiguity / dispute, arising on account of interpretation in version other than English, English version will prevail.
