#### II.A. MINIMUM EDUCATION QUALIFICATIONS:

Selection will be based on percentage of mark scored by the candidates in all the subjects in ITI examinations (NCTV) of the respective trade.

#### II.B. OTHER ELIGIBILT Y REQUIREMENTS:

1. Age Limit: The minimum age limit is 14 years & there is no upper age limit as per apprenticeship Act 1961.
2. Candidates should have passed the qualifying exam in 2021/2022/2023.
3. Candidate should be belonging to the State of Rajasthan are only eligible.
4. Candidate should not have undergone or presently undergoing Apprenticeship Training in NLC India Limited or elsewhere.
5. Candidate should not have experience of one year or more in any job.

Applicants desiring to avail age relaxation under OBC category ought to submit the valid OBC Certificate (Back Class/ Most Backward Class Certificates shall not be accepted for consideration under OBC).

#### III. RESERVATION OF VACANCIES:

Guidelines under Apprentices Act on Reservation for SC/ST/OBC/EWS/PWD will be followed. Those who are claiming reservation under SC/ST/OBC/EWS/PWD shall provide certificate as per Government standard format, failing which their claim for reservation will be considered as 'General' category only. BC/MBC candidates claiming OBC (Non creamy layer) category should submit OBC (NCL) certificate as per the approved (OBC\_NCL) format from the certificate issuing authority.

Out of total training slots/seats, 50% of the Training slots have been allotted for Candidates passed out from Rajiv Gandhi ITI, Barsingsar-334402, Bikaner District, Rajasthan & Wards of Project Affected Persons (PAP'S) of Barsingsar Project & 10% have been allotted for Wards of the employees of NLCIL.

#### IV. INSTRUCTION TO CANDIDATES:

1. The Candidate will have to arrive at the percentage of marks obtained in the qualifying examinations as stated below and enclose it along with the application form.(refer Specimen format).
2. Overstatement of Marks by the candidates will lead to disqualification of the candidates from selection process.
3. Any misrepresentation/forgery of facts in the qualifying examination will lead to direct disqualification and may face legal consequences.
4. In case of more than one candidate scoring the same percentage of marks at the cut-off level, the senior most candidates will be considered for selection, based on the date of birth.
